PLUS Loan Request Form



The Federal Direct Parent PLUS Loan is available to the parents of dependent undergraduate students who are enrolled in at least six (6) credits. A parent may borrow up to the total of the Cost of Attendance minus all financial aid and other resources received by the student. To apply for a PLUS loan, the student and parent must first complete the Free Application for Federal Student Aid (FAFSA). The parent must then complete this form and return it to the Office of Financial Aid Services. A new request form is required for each loan period.

The Federal Direct PLUS loan uses a Master Promissory Note (MPN) which is active for all subsequent Direct PLUS loans for a period of up to 10 years. If the parent borrower does not have a active MPN on file, he/she may complete one online at www.studentloans.gov.
