HACC encourages MBE and WBE firms to submit a Proposal for the Work and all bidders to proactively solicit MBE and WBE firms in the bidding and subcontracting process.

The work will be performed under a Single Prime Contract and consists of the removal of the existing Strand theatrical dimming patch bay and the (84) associated circuits with Stage Pin receptacles located in the ceiling and on the walls of the Black Box Theater. Demolition of the existing patch bay and existing (84) circuits is required. A new distribution panel with (24) Stage Pin receptacles shall be installed in the center of the Black Box Theater. The new (24) circuits shall be run back to the existing "Sensor" ETC dimmer rack. DMX-512 control cabling shall be provided from the existing lighting control board to the existing "Sensor" ETC dimmer rack.
