This Addendum is hereby made part of the Plans and Project Manual dated July 11, 2013, for the above referenced project. The provisions of this Addendum are intended to supplement the provisions of the Plans and Project Manual and/or supersede them where contradictory thereto.

This Addendum contains changes to the requirements of the Plans and Project Manual. Such changes shall be incorporated into the Plans and Project Manual and shall apply to work with the same meaning and force as if they had been included in the original Plans and Project Manual. Where this Addendum modifies a portion of a paragraph or phrase of the Project Manual, the remaining unmodified portion of the paragraph or phrase shall remain in force.

The conditions and terms of the Plans and Project Manual shall govern work described in this Addendum. Whenever the conditions of work, or the quality or quantity of materials or workmanship are not fully described in this Addendum, the conditions of work etc. included in the Plans and Project Manual for similar items of work shall apply to the work described in this Addendum. If no similar items of work are included in the Plans and Project Manual, the quality of material and workmanship shall be subject to the written acceptance of the Architect.

1.1 PRE-BID MEETING MINUTES

Meeting minutes from the Pre-Bid Meeting held on August 1, 2013 are attached and are a part of this Addendum. In the event of a conflict between the information contained in the Pre-Bid Meeting Notes and the Drawings, Specifications and responses to questions contained in this Addendum, the latter shall take precedence.

- A. A second site visit will take place on Friday, August 9, 2013. All Contractors interested in attending, shall meet in the lobby located inside of the southeast entrance at 10:00AM.

- D. Remove all references to the project sign. No sign will be required.

- 1.5 All questions are to be directed to Greg Lamay in the office of the Construction Manager in writing via fax or e-mail: Fax (717) 233-1666, E-mail: epcm@easternpcm.com. The last day for questions is August 14, 2013.
- 1.6 Addenda will be emailed or sent via Fed-Ex, depending on the size of the document. Addendum #1 will be issued approximately one week after the Pre-Bid meeting. Additional Addenda will be issued as required.
- 1.7 This project is subject to PA Prevailing Wage Rates as described in Specification Section 00820.
- 1.8 The general construction permit will be paid for and obtained by the Owner. Trade specific permits are to be obtained and paid for by applicable contractors in accordance with jurisdictional requirements.
- 1.9 Project Overview

The work will be performed under a Single Prime Contract and consists of the construction of an "In Situ Lab", an observation/computer room, and a new "Sim-Man Room". The work will include selective demolition, construction of drywall partitions, hollow metal doors, clerestory aluminum windows, painting, dust protection, and associated mechanical, electrical and plumbing systems to support the renovations.

Working hours will be from 10:00PM – 7:00AM.

- 1.10 Contractor parking and staging will be discussed at the Pre-Construction Meeting, but will be accommodated in the parking lot adjacent to the SMHEP building.
- 1.11 Dust must be completely contained in the areas of construction.
- 1.12 Staff and student access to lab areas, including storage rooms, must be maintained at all times during construction.
- 1.13 Daily cleanup of the job site will be the responsibility of the Contractor. The active campus is expected to stay clean and clear of any construction equipment, supplies and/or debris at all times.
- 1.14 Contractor must provide protection of existing installations.
- 1.15 Contractors may access the nursing lab via the south stair and/or the elevator. Contractor must provide protective pads for the interior of the elevator if it is going to be utilized. See attached "Exhibit A".
- 1.16 Contractor's dumpsters will be located in the back of the SMHEP building adjacent to HACC's dumpsters.
- 1.17 All vehicles, equipment and materials must be kept off of the grass/landscaped areas on campus.
- 1.18 A tour was conducted after the meeting.




