This Addendum is hereby made part of the Plans and Project Manual dated November 17, 2009 for the above referenced project. The provisions of this Addendum are intended to supplement the provisions of the Plans and Project Manual and/or supersede them where contradictory thereto.

This Addendum contains changes to the requirements of the Plans and Project Manual. Such changes shall be incorporated into the Plans and Project Manual and shall apply to work with the same meaning and force as if they had been included in the original Plans and Project Manual. Where this Addendum modifies a portion of a paragraph or phrase of the Project Manual, the remaining unmodified portion of the paragraph or phrase shall remain in force.

The conditions and terms of the Plans and Project Manual shall govern work described in this Addendum. Whenever the conditions of work, or the quality or quantity of materials or workmanship are not fully described in this Addendum, the conditions of work etc. included in the Plans and Project Manual for similar items of work shall apply to the work described in this Addendum. If no similar items of work are included in the Plans and Project Manual, the quality of material and workmanship shall be subject to the written acceptance of the Engineer.

1.1 CHANGES TO THE DRAWINGS

a. Drawing #1 Site Plan

ADD the following to General Notes:

6. All disturbed areas shall be seeded and mulched per PennDot Publication 408, Section 804 and 805. Seed mix to be Formula "B".

b. Drawing #2 Details

REPLACE Drawing #2 Details with Attached Drawing #2 dated November 16, 2009.

c. Drawing #2 Details

ADD Drawing No. 1 Concrete Paver Section with Plastic Edge Restraint, dated December 1, 2009.

1.2 CLARIFICATIONS

- a. Space for staging will be available and coordinated on site.
- b. All traffic control must be in accordance with City of York and PennDot requirements.
- c. In the event of discrepancies between specifications and the City of York or PennDot Requirements the more stringent requirement shall apply.

1.3 PRE-BID MEETING MINUTES

Meeting minutes from the Pre-Bid Meeting held on November 24, 2009 are attached and are a part of this Addendum. In the event of a conflict between the information contained in the Pre-Bid Meeting Notes and the Plans and Project Manual and responses to questions contained in this Addendum, the latter shall take precedence.
