Dual Admission

A Dual Admission Agreement is a cooperative partnership between HACC and a 4-year college or university that facilitates the admission process for students interested in pursuing their bachelor's degree. The agreement prepares HACC students to transfer their associate degree credits into a bachelor degree program providing the student maintains the required academic standard and follows the requirements of a program parallel to the desired transfer program.

Advantages of Dual Admission

- Simplified transfer process (reducing transfer shock)
- Early transfer planning from HACC and 4-year institution
- Official transcript reviewed by 4-year institution every semester (HACC will send transcript for FREE!)

These advantages vary by institution:

- Updates on news and events at 4-year institution. Possible discount to 4-year school events
- Access to 4-year institution's facilities while a HACC student (career services, library, gym)
- Scholarship opportunities
- Application fee waived

How to Enroll in a Dual Admission Program

If you are interested in signing a Letter of Intent to enroll in a Dual Admission Agreement, see your HACC Advisor or Counselor at your HACC campus.

Special Note:

Students may enter into only **one** Dual Admission agreement at a time and before **30** transferable credits are earned (some exceptions may apply). Students may withdraw from the dual admission program at any time by notifying both the 4-year institution and the enrollment service center at their HACC campus:
