Thank you for your interest in our PHRN program. We are pleased to announce that our next program will begin on Tuesday, 8th September, 2020 at 8:00am at the Shumaker Public Safety Center on the Harrisburg campus of Harrisburg Area Community College.

Our classroom sessions will be conducted each Tuesday from 8:00am – 4:00pm until our anticipated course completion on February 23, 2021. Tuition for the program is \$1,500.00 (does **NOT** cover the cost for textbook). Those students who successfully complete our program will be eligible to take the Pennsylvania Department of Health certification exam(s).

Please send the application and supporting documentation listed on the application to our office prior to August 7th. All paperwork, including the health form and background checks, will need to be submitted no later than the first day of class.

 3. 3 Letters of recommendation - All letters are to be sent directly by the references to **EMS Education Unit, Attn: Kimmin Kalyaniwala, HACC-SPSC, 1 HACC Drive, Harrisburg, PA 17110**. Do not use relatives. Include at least one reference from a Healthcare Provider/Professional.
