This Addendum is hereby made part of the Plans and Project Manual dated April 22, 2014, for the above referenced project. The provisions of this Addendum are intended to supplement the provisions of the Plans and Project Manual and/or supersede them where contradictory thereto.

This Addendum contains changes to the requirements of the Plans and Project Manual. Such changes shall be incorporated into the Plans and Project Manual and shall apply to work with the same meaning and force as if they had been included in the original Plans and Project Manual. Where this Addendum modifies a portion of a paragraph or phrase of the Project Manual, the remaining unmodified portion of the paragraph or phrase shall remain in force.

The conditions and terms of the Plans and Project Manual shall govern work described in this Addendum. Whenever the conditions of work, or the quality or quantity of materials or workmanship are not fully described in this Addendum, the conditions of work etc. included in the Plans and Project Manual for similar items of work shall apply to the work described in this Addendum. If no similar items of work are included in the Plans and Project Manual, the quality of material and workmanship shall be subject to the written acceptance of the Architect.

1.1 PRE-BID MEETING MINUTES

- 1.4 All questions are to be directed to Greg Lamay at the office of the Construction Manager in writing via fax or e-mail: Fax (717) 233-1666, E-mail: epcm@easternpcm.com. The last day for questions is May 9, 2014 at 12:00PM.
- 1.5 Addenda will be issued as required via email. Meeting minutes from the Pre-Bid Meeting will be included in the first Addendum anticipated to be issued May 2.
- 1.6 A Building Permit, if necessary, will be obtained and paid for by the Owner. Trade specific permits (i.e. Electrical, etc.) are to be obtained and paid for by applicable contractors in accordance with jurisdictional requirements.

Post Meeting Note: No Building Permit will be required. Contractor shall submit application and obtain Electrical Permit.

1.7 Project Overview

The work will be performed under a Single Prime Contract and consists of demolition and removal of an existing 500kW diesel generator and installation of a new 60kW generator. The work also will require the addition of new emergency load center(s) and re-circuiting of emergency lights throughout the approximately 100,000 sf building. Selected critical loads will also be connected to the new emergency power circuits.

Post Meeting Note: The Generator will be an 80kW generator

- 1.8 There are 2 potential alternates being discussed. Details and specifications will be issued via addendum if the Owner chooses to pursue them. They are as follows:
 - 1. In lieu of a diesel powered generator, the Owner may choose to utilize natural gas if capacity is sufficient.
 - 2. In lieu of removal from the site, the Owner may wish to retain the generator. Information regarding location to be delivered will be provided via addendum.
- 1.9 Work Hours were discussed and are as follows:

All work is to be performed Monday – Friday 7:00 am – 5:00 pm. Work throughout the classroom and common areas will be performed between 10:00 pm – 6:00 am or otherwise coordinated with the College. Work performed outside of these hours requires approval of the Owner and Construction Manager. The Owner further offered that Fridays in the summer may present opportunities to perform some of the "off-hour" work as the Campus is closed for class and staff.

- 1.10 It was noted that any work requiring temporary disruption of services, including fire alarm coverage, would have to be coordinated with the College prior to performing the work.
- 1.11 Daily cleanup of any area that is impacted by construction will be the responsibility of the Contractor.

- 1.12 A site tour was conducted.
- 1.13 The following questions were recorded:
 - 1. Will all specifications including supply locations be issued regarding potential Natural Gas option?
 - Answer: yes, they will be issued via Addendum
 - 2. There is conflicting information regarding existing concrete pad whether it is to remain or not.
 - Answer: It will be clarified via addendum
 - Will Service and Monitoring be required by the Contract?
 Answer: if not already specified in the Contract documents, clarification will be issued via addendum
 - 4. There is a conflict in documents regarding the size of the generator, what size is intended?
 - Answer: the generator will be an 80 kW generator. A Correction will be included in the addendum.
 - 5. There is some confusion regarding the light fixtures, which ones are to be reused? Answer: The documents will be reviewed, if there is any discrepancy in the documents, it will be clarified by addendum.
 - 6. Will a building permit be required? Answer: As stated previously in minutes, any trade specific permit is the responsibility of the Contractor. A building permit, if applicable, would be obtained and paid for by the owner.

Post Meeting Note: a call to the City of York has verified that no building permit is required, an electrical permit is required and must be obtained and paid for by the Contractor.
