OBJECTIVES:

Harrisburg Area Community College relies heavily on the ability to record student speeches in multiple modalities of instructions and captures the use of technology assisted visual aids during recording. In addition, General Education Assessment also incorporates recorded speeches as possible artifacts for assessment.

The goal is to find a solution that:

- Allows students to self-record speeches and technology assisted visual aids in an online environment that permits students to self and peer review speeches.
- Additionally, it needs to provide classroom solutions to recording speeches. The technology needs to be easy to use for both students and faculty with limited training, as close to a one button solution as possible.
- The system should also be able to handle file management and storage needs while incorporating the possibility of using the media for assessment purposes.
- Any solution should work for online environments and face to face environments.
- As students may be using the system at all times, uptime and support are necessary.

ADDITIONAL NOTES:

HACC is requesting that the vendors provide a best practice or recommendation for hardware as it relates to their solution and how it should be used in the classroom and through our online classes. As part of this request, HACC would like 1) to conduct interviews for select vendors and 2) have use of potential solutions for a short period of time to see whether it meets the requirements that will be tested.

HACC would prefer that vendor provide references that are situated within a 100 mile radius of HACC, located at 1 HACC Drive, Harrisburg, PA 17110.

Following interviews and demos, it is the intention of HACC to create a RFP as quickly as possible because HACC needs the proper system installed and trained on by the Fall Semester 2015 and in full operation by Spring 2016.
