The Centers for Disease Control and Prevention (CDC) recently issued revised <u>guidance</u> related to masks. 1. What is the status of student disbursements from the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan (ARP) funds?

Disbursements of funds to students will begin the week of Aug. 9, 2021, and continue for the next several weeks. Eligible students were notified via email on Aug. 3. For more information, please visit <u>hacc.edu/CARESact</u>.

2. Will the bookstores be offering book buyback for cash in August, and how do I

return my summer rentals?

The Gettysburg, Harrisburg, Lancaster and York campus bookstores will reopen on Aug. 16. Store hours will be Monday-Thursday from 8 a.m. to 4:30 p.m. Book buyback will be offered when the bookstores are open.

3. How do I order course materials for the fall 2021 semester?

The list of required and optional course materials for the fall 2021 semester is available on the bookstore <u>website</u>. Financial aid will be available to use on Aug. 9.

Please note the following:

- There will be a \$4.95 shipping fee for each order shipped via UPS.
- Customers placing a web order will have the option to pick up their order at any campus bookstore during open store hours, which start Aug. 16.
- Textbooks and other required course materials need to be pre-ordered online through the fall 2021 semester even if you choose in-store pickup.
- Not all textbooks and other course materials will be available to purchase at all campus bookstore locations.
- School and office supplies and HACC-imprinted merchandise (such as clothing and gift items) will be available to purchase at all campus bookstore locations.
- Apple[®] products will be available to purchase in the Harrisburg Campus bookstore or online.
- There is no longer a bookstore on the Lebanon Campus. Customers can pick up their orders starting on Aug. 30 at the campus Learning Commons Desk on the third floor.

4. Do I need to self-screen before coming to a HACC campus?

Please continue <u>self-screening</u> (pdf) each day. Although HACC is no longer providing wellness screening for you, it is important to evaluate how you feel.

5. What do I do if I have been in contact with someone who tested positive for COVID-19 or if I have symptoms or test positive for COVID-19?

Note that if you are feeling any symptoms of COVID-19 or have had a fever over 100.4 degrees within 48 hours prior to coming to campus, **please do NOT come to campus**. Please notify the College by emailing <u>corona@hacc.edu</u>. Please describe whether you tested positive, have symptoms or have been in contact with someone who has tested positive. Contact is defined as within 6 feet for 15 minutes or more. This process is required for vaccinated and unvaccinated individuals.

6. I plan to take on-campus classes this fall. Will there be food options available?
