HACC is honored to be included as a [site for COVID-19 vaccination](#) distribution. Please note that **this is NOT a HACC event**. Dauphin County and UPMC are managing the entire process.

Please note:

- Dauphin County and UPMC **will be distributing the COVID-19 vaccine** on the Harrisburg Campus in the West Lot (Entrance: Gate 2) March 22, 2021, through at least June.
- To limit the possibility of any COVID-19 exposure for our students and employees and out of respect for Dauphin County and UPMC, on the dates of distribution, **we will close the West Lot where the vaccines will be distributed**. All students and employees should park in the East Lot (Entrance: Gate 1). Please note: There will be no changes to class schedules.
- At this point in time, **the vaccine is not for public access**. Unless invited by Dauphin County or UPMC, you are not authorized to access the vaccination distribution site. Vaccine registration for this location will be through [UPMC registration](#). Dauphin County will develop, communicate and manage all guidelines and procedures for vaccine distribution, eligibility and enrollment.
