# 4. Is it true that the College is going to post a request for proposal (RFP) for student counseling services and the employee assistance program (EAP)?

As you know, the College is continually reviewing processes, procedures and partnerships to ensure that we are best serving our students and employees.

In November 2020, HACC's contracted service plans for student counseling (in place for one year) and EAP services (in place for seven years) will expire with Mazzitti & Sullivan. Thus, as part of our normal practices to ensure quality services to our students and employees, the College will issue one RFP that will cover both our student and employee counseling services. This RFP is a standard business practice, meant to assess the best available options for our students and employees.

Mazzitti & Sullivan has been encouraged to respond to the RFP. If they are chosen from the RFP process, nothing will change. You will be updated on the status of the RFP process in December.

Although our contracts with Mazzitti & Sullivan expire in November 2020, they have agreed to extend the contracts through Jan. 11, 2021, to ensure you and our students will have access to counseling services through fall and winter 2020. The selected provider from the RFP will be in place by the spring 2021 semester.
