## 1. Why do we continue to hire employees after the College announced a hiring freeze?

In an effort to help offset the reduced enrollment caused by the pandemic, we reviewed all open positions and picked those that we could cover functions on a temporary basis until we see our enrollments improve.

Full-time positions that are currently vacant are being frozen. **This impacts 31 unfilled full-time positions.** However, we did not freeze all open positions. The hiring freeze does not include part-time or grant-funded positions. This proactive effort was to help against potential active staff reductions.

2. With all the unrest surrounding racism, what is our Police Academy doing to ensure they are graduating cadets who will not try and murder people who look like me, on impulse?

We have a profound respect for our communities and are responsible for ensuring that our <u>Police Academy</u> graduates are trained to the highest standards. Toward that end, we have added two to three days of training to the Academy focused on diversity and inclusion, communication and de-escalation. Additionally, we are committed to planning two conferences on diversity and inclusion annually for first responders within the communities we serve. We will implement the additional training with our current Academy and plan to have the first conference in January 2021.

3. **Do you have any updates about the fall 2020 virtual Commencement ceremony?**The fall 2020 virtual Commencement ceremony will be held on Dec. 15 at 6 p.m. to celebrate the accomplishments of our spring and fall 2020 graduates.
