1. The summer courses don't have any teachers assigned to the classes. Will they be assigned by the opening of registration on April 1?

The summer schedule had to be re-built following the extension of the spring semester. We completed the summer schedule and are now staffing the classes. Staffing should be mostly complete in the next few weeks.

2. I was hoping to test out of math before the semester ended. Any plans for placement testing?

Unfortunately, we do not have a substitute for proctored placement testing yet. However, we have changed our <u>math and English placement guidelines</u>. For example, if you have a B or better in Algebra II or a B or 3.0 GPA from your high school in the last five years, you are eligible to register for college-level math with the submission of your high school transcript.

3. I have a rented book due to be returned by May 17. Will I be able to go to the bookstore and return it then?

The spring 2020 textbook rental due date has been extended to May 28.

4. How can I set up a time with my advisor to discuss what classes I should take? I also need assistance with applying for financial aid.

Most HACC employees continue to work remotely. Students who need support from advisors, financial aid or the Welcome Center should contact 800-ABC-HACC and select the appropriate office to get the support they need.

5. Will there be any refund or exemption for students who were forced to take Zoom classes? Or will we receive a credit allowing us to take the class over the summer?

Since classes continue with remote instruction, there will be no tuition refunds issued. Students should continue to attend class remotely and work toward successful completion of the course.
