On July 1, 2020, Governor Wolf [announced](#) a new order signed by Secretary of Health Dr. Rachel Levine that requires individuals to wear masks any time they leave their home. As you know, students and employees who are approved to be on a HACC campus for certain courses must follow [specific guidelines](#), including wearing a mask that covers the nose and mouth. These are mandatory requirements that have been put in place for your safety and the safety of others.

As Dr. Levine said, “While cases increase in some areas, we cannot become complacent. My mask protects you, and your mask protects me. Wearing a mask shows that you care about others, and that you are committed to protecting the lives of those around you.”

Eventually, courses will be labeled as “remote” or “online” in the “Instructor/Meeting Times” field on [the class schedule](#). The deans are revising the schedules so some classes marked as on a campus will be updated to remote in the coming days. If a lab requires work on a campus, it will be labeled with the actual building at that campus location.
