- 1. I am disappointed with the decision to close HACC’s campuses through the fall semester. That is not fair to students who want to come to campus and learn.**

The decision to conduct the fall 2020 semester in a mostly remote format was not one that the College took lightly. HACC convened a task force of students and employees to examine options. After weeks of careful deliberation and research,

that task force determined that this mostly remote approach is the best way to ensure the safety of all in our College community while also allowing students to continue their education.

Not everyone will be happy with this decision, but given the great uncertainty about what COVID-19 will do in the weeks and months ahead, we are confident that this decision protects our most important resources: our students and employees.

**2. Does HACC plan on recognizing Juneteenth as a holiday or at least some form of support? This is now recognized as a state holiday. How can we get involved?**

#### **4. Are there any tuition giveaways to support HACC students for the fall semester?**

Thanks to the [HACC Foundation](#), 40 \$2,000 tuition giveaways will be awarded to current and future HACC students for the fall 2020 semester.

These are not scholarships. Students do not have to apply for the tuition giveaways through AcademicWorks, the online scholarship management system. Instead, students may enter the drawing for a \$2,000 tuition giveaway by completing the [online form](#) and [registering for classes](#).

The \$2,000 will be applied to the winners' [tuition and fees](#) for the fall semester only. The \$2,000 covers almost nine credits!

#### **5. How, and when, will we know which hands-on and observation-required classes are remote instruction or not?**

We are in the process of rebuilding the fall schedule right now. Deans are working with faculty to determine how many times students will need to visit campus to complete the hands-on components, and which components can be completed remotely. This process will take several weeks in light of the large number of courses that we are rescheduling. We appreciate your patience as we rebuild the schedule.

Once it is complete, we will include the exact days and times that students will be required to visit campus for the hands-on components. It will be similar to how we currently indicate the day, time and room assignment for labs.

#### **6. When will the campus gyms and pools be open for use by students, alumni and community members?**

All HACC campuses remain closed through Dec. 31, 2020. Therefore, all exercise

facilities on our campuses are also closed.

**7. How can students get books from the bookstore for fall?**

Students can order books online at [bookstore.hacc.edu](http://bookstore.hacc.edu). Textbooks for fall classes will be shipped to students at no cost. Payments through financial aid, credit card, check or HACC bookstore gift card will be accepted. Students can also order course materials, school supplies, HACC spirit gear and electronics online.

**8. Will the College provide food service for students and employees on campus in the fall?**

HACC campuses remain closed through Dec. 31. Food services will not be available. Only essential personnel or employees and students involved in the approved programs will have access to the campuses.

**9. If students do not sign up for BankMobile disbursements, does that mean we will not receive money from the CARES Act? How do students know if they are eligible? Can students have the funds mailed like refunds?**

If a student meets the eligibility criteria for CARES Act emergency financial aid grants and is not using BankMobile for their disbursements, a check will be mailed to the student's address on record in myHACC.

**10. How can a student apply for the CARES Act at HACC?**

**11. How will the CARES Act be refunded to students? Is it the same account as financial aid disbursements?**

Students who met the federal guidelines for CARES Act emergency financial aid grants were notified via email on June 18 that they would be receiving a grant. HACC disbursed the funds through our current [financial aid refund process](#) via BankMobile. **12. I am a current student and enrolled for the fall. Will I still receive aid through the CARES Act? Is there a form that I need to fill out?**

Students do not need to fill out any forms to receive the CARES Act emergency financial aid grants. Further details about eligibility and the process are available at [hacc.edu/CARESact](http://hacc.edu/CARESact).

13. **There are several groups scheduled to use space on the Harrisburg Campus starting Aug. 17, 2020. Will they be unable to utilize it until we are all back to campus? And what about events such as walks/runs and car shows?**

HACC campuses remain closed and all internal and external campus events are canceled through Dec. 31, 2020.

However, the College remains open with remote and online classes and services for the summer and fall 2020 semesters.

Only approved credit and Workforce Development programs with required hands-on/experiential components to meet learning outcomes will be permitted on-campus.

Masks are required for anyone on campus and must cover the mouth and nose. Social distancing is also required with at least 6 feet of distance between individuals.

14. **I want to help other students be successful with remote instruction. How can HACC use my experiences to help others be successful with remote instruction?**

We are seeking written and video testimonials from students who were hesitant, scared or worried about taking a remote instruction class, but overcame these feelings after starting the class.
