**2. I'm taking microbiology this summer beginning on June 16. How can I find out what textbook is required and how can I purchase the textbook?**

Textbooks will be shipped to students for summer classes. Students must order books from HACC's [online bookstore](#).

All campus bookstore locations will offer free shipping. Payment may be made via financial aid, credit card, check or HACC bookstore gift card. In addition to textbooks, you can also order your class materials and school supplies from the bookstore. All ordering instructions are on the bookstore website.

**3. Why are students required to pay a chemistry fee when we are not even doing experiments on campus?**

Lab fees for science courses such as chemistry are used by the College to help defray the overall annual costs associated with offering these classes. This includes the maintenance of equipment and supplies, implementation of safety protocols and direct costs. With remote instruction, faculty are still running and filming experiments in the labs to provide demonstrations for students.
