**1. When will spring diplomas be mailed to students?**

Diplomas will be mailed to graduates in mid-to-late June, which is when spring graduates typically receive their diplomas.

**2. I am an international student who will graduate in fall 2020. I'm taking nine credits in online courses this summer and will have seven credits remaining for the fall semester. Can I take these classes online from home? I go back home in June, and I**

**don't know if I will be able to return to the United States during the pandemic.**

If your last seven credits are available online, you will be able to complete your degree online. Please contact your advisor to discuss how you can complete your degree, certificate or diploma at HACC.

**3. When is the cutoff for TEAS testing? When is the cutoff to apply to the RN and LPN programs? When will the students be notified if they got into the program or not?**

Deadlines for applying to our nursing programs are:

- RN: June 22
- LPN: July 2

The TEAS test needs to be completed in advance of those deadlines. You may register at the ATI website, [www.atitesting.com/ati\\_store/TEAS-Products.aspx](http://www.atitesting.com/ati_store/TEAS-Products.aspx).

To be eligible to apply for clinicals, your TEAS (overall (composite/percentage) score must be 60 or higher for LPN and 70 or higher for RN.
