The Paralegal Studies AAS degree, which is approved by the American Bar Association (ABA), develops professional competence and prepares students to provide paralegal services, under attorney supervision, or other law-related services in private, corporate and governmental law offices. The ABA requires students to take at least nine semester credits, or the equivalent, of legal specialty courses through synchronous instruction. Students may complete this program at the Harrisburg and Lancaster campuses through various modalities (e.g., on-campus/in-person instruction, hybrid, synchronous remote instruction and/or asynchronous instruction).

Paralegals may not provide legal services directly to the public, except as permitted by law.

Career Opportunities

Graduates are likely to be employed in a variety of law-related positions, including as paralegals in private and corporate practice, government agencies, insurance companies, and federal, state or local courts. Transfer options are available for students wishing to pursue their bachelor's degree.

- Use current legal technologies consistent with professional standards
- Respond appropriately to the ethical issues that arise for a paralegal in a legal environment

Paralegal Studies AAS Course Transfer Policy

In addition to the requirements of HACC's transfer policy, credits may be transferred in and applied to paralegal specialty courses only if they meet all of the following requirements:

- Credits must have been earned at a college or university accredited by one of the following regional accrediting agencies: Middle States, New England, North Central, Northwest, Southern, or Western;
- Credit will be awarded only for course work in which the student received credit with a letter grade of 'C' or better;
- The course content must be comparable to the course offered in HACC's Paralegal Studies Program;
- Students must take at least nine (9) semester credit hours of required Paralegal Studies legal specialty courses through synchronous instruction;
- Continuing Education Credits are NOT accepted for transfer.

The Paralegal Program Director shall review the course syllabus or catalog description of the course which the student is attempting to transfer to ensure that the transferred course meets the requirements of this policy.

In the AAS program, no more than three of the seven required legal specialty courses and no more than three of the six elective legal specialty courses will be accepted for credit.

In all program options, credits for PLGL 104 (Legal Research & Writing II), PLGL 202 (Civil Litigation II), and PLGL 210 (Paralegal Ethics and Professionalism), may NOT be transferred into the program.
